Announcement of public selection, based on qualifications and a research project, to award 5 research fellowships according to section 22 of L.240/2010, co-financed by the European Social Fund (DIANET Project – *incoming*).

1. Purposes

The purpose of this announcement is the development of human potential in research for the benefit of the scientific and academic system of the Friuli Venezia Giulia region, through research initiatives conducted by foreign researchers who can benefit from the synergies and connections of the Network made up of the member universities of the Alps-Adriatic Rectors' Conference, of the Danube Rectors' Conference, and other public or private research institutions maintaining institutional relations with them.

In line with EU regulations, the University of Udine pursues the objective of providing equal opportunities to male and female candidates.

2. Fellowships to conduct research activities

A public selection is hereby announced for 5 fellowships of one year duration to conduct research activity.

The financial resources for one year (12 months) of fellowship, come from the 2007/2013 European Social Fund Operational Programme of the Autonomous Region Friuli Venezia Giulia.

The candidate must submit a research project according to the procedures provided for in item 4.2.

3. Eligible candidates and admission requirements

Eligible candidates for the research fellowship as mentioned in this announcement, must, within the date of submission of the application:

- a) possess at least one of the following university degrees awarded by one of the member Universities of the Network, as per Annex A) which is an integral part of this announcement:
 - I. second-cycle university degree – equivalent or equipollent to the following Italian university degrees:
 - i. "diploma di laurea" – university degree according to the system in force before D.M.509/1999;
 - ii. "laurea specialistica" – master's degree according to the system come into force with D.M.509/1999;
 - iii. "laurea magistrale" – master's degree according to the system come into force with D.M.270/2004.
 - II. Ph.D. degree (third-cycle university degree);
 - III. degree awarded by medical schools of specialisation (third-cycle university degree). With regard to the eligibility of candidates possessing degrees by foreign universities which are not equipollent, the examining board will decide on the equivalence of their degrees for the sole purposes of the selection.
- b) hold a non-Italian citizenship. In case of dual citizenship, one of which is Italian, the latter prevails

- therefore making its holder ineligible for the selection (L.218/1995, on reform of the Italian system of private international law, section 19, paragraph 2);
- c) be domiciled (permanent resident) on the territory of one of the member Institutions of the Network as per Annex B), which is an integral part of this announcement. This requirement must be possessed also at the start of the project;
 - d) not be older than 40 years on the date of application submission;
 - e) have conducted, in the three years immediately before the date of publication of this announcement, and for at least six months, documented postgraduate (secondcycle level) research activity, at universities, research centres, companies, laboratories or other public or private institutions, in fields pertaining to the research project that is being submitted for selection.

The following are excluded from applying:

1. those who have already been awarded research fellowships in accordance with L.240/2010, for a total of four years, even if non-continuous, with the exclusion of the period when the fellowship coincided with the Ph.D. course, not exceeding its legal duration;
2. those who hold another fellowship, who are enrolled in Bachelor or Master degree courses (first and second-cycle university degree courses), medical schools of specialisation as per D.Lgs.368/1999, postgraduate continuing education courses (Italian "Master"), in Italy or abroad, who have an employment contract and, in the case of permanent employees, this entails unpaid leave in accordance with the provisions of the law and of the current collective bargaining agreement;
3. those who hold scholarships or fellowships of any kind, with the exception of those awarded by Italian or foreign institutions with the aim of integrating the research activity with a period spent abroad;
4. those who are related within the fourth degree of consanguinity or affinity: -to the Rector, the Director or a member of the Board of Directors of the University of Udine - to the scientific supervisor or to a professor of the Department where the research is to be conducted;
5. those who are permanent employees of universities, of public institutions of research and experimentation, of the National Agency for New Technologies, Energy and Sustainable Economic Development (ENEA), of the Italian Space Agency (ASI), or of institutions that award scientific specialisation degrees ("diploma di perfezionamento scientifico") which are equipollent to Ph.D. degrees in accordance with section 74, paragraph 4 of D.P.R.382/1980.

4. Application for the selection procedure and submission of research project

The applications for the selection procedure shall be submitted with the hereunder listed documents, mandatorily using the appropriate forms enclosed with this announcement:

- 2 self-certifications of the candidate – sections 46 and 47 of D.P.R.445/2000 (Annex 1.A);

All forms and documents shall be written either in Italian or in English. No other languages are allowed.

Please note that each file and/or folder, compressed in ZIP or RAR format cannot be larger than 5 MB).

The electronic documents without digital signature shall not be considered as signed, in conformity with the current legislation. Similarly, no electronic copies of analogic documents sent through the registered e-mail service shall be accepted. Static, not directly modifiable formats must be used, without macroinstructions or executable program codes, preferably pdf and tif, or non-proprietary formats such as odf, txt and xml. Proprietary formats instead must not be used (doc, xls, etc.). We remind that the acknowledgement of receipt is sent directly from the registered e-mail service provider, and that calling the university offices or sending further e-mails to ascertain the receipt which is inherently certified, is therefore unnecessary, as is unnecessary sending subsequent hardcopy forms and documents.

Documents and forms submitted after the application deadline shall not be considered.

The signature to the application form does not require authentication, if appended in the presence of the clerk in charge or accompanied by a non-authenticated photocopy of valid passport or identification document of the signer (section 38, paragraph 3 of D.P.R.445/2000).

The above mentioned application and the therein contained self-certifications are exempt from stamp duty according to section 1, L. 370/1988, and to section 14, paragraph 2, of the Table annexed to D.P.R.642/1972.

The application must contain all the necessary indications to unambiguously identify the selection to which the candidate wants to apply. For this reason the candidate must write the following on the envelope:

In the application the candidate must indicate the mailing address chosen for the purposes of the selection procedure and must promptly communicate in written form any possible variation.

The University of Udine shall not be liable if the candidate cannot be reached or if communications are lost due to wrong indication of the domicile (permanent residency) or mailing address chosen for the purposes of the selection or due to the missing or late communication of their variation, nor due to possible post or telegraph errors for which the University of Udine is not at fault.

The candidate who is recognised as differently abled must specify in the application the necessary aid for his/her disability, according to L.104/1992.

The candidate who wants to exercise the right as per L. 413/1993, must declare his/her conscientious objection to animal experiments.

4.1 Submission of academic qualifications and published works

The candidate must enclose with the application form all the documents, qualifications and published works that he/she deems useful for the purposes of the selection, and a list thereof in a single copy, using the enclosed Annex 1.A.

The citizens of EU member States can submit the above mentioned original documents or true copies thereof or copies certified as true to the originals through self-certification affidavit according to section 19 and 47 of D.P.R.445/2000.

They can also prove their possession of the qualifications and documents through self-certification or

self-certification affidavit according to section 46 and 47 of D.P.R.445/2000.

The citizens of non-EU States, legally residing in Italy according to the provisions in force, can use self-certifications as per above mentioned sections of D.P.R.445/2000 solely for status, personal qualities and facts that can be certified or attested by Italian public institutions, without prejudice to the special provisions contained in the laws, in the regulations on immigration control and status of the foreigner, and in the international agreements between Italy and the country of origin of the declarant.

The certifications issued by the public administration as per status, personal qualities and facts are valid and can be used solely among private bodies. With public institutions and providers of public services, certificates and affidavits are substituted by self-certifications and self-certification affidavits (section 40 of D.P.R.445/2000)

With the exception of the cases foreseen in the above paragraphs, status, personal qualities and facts are documented through certificates or attestations issued by the competent authority of the foreign State, accompanied by a translation into Italian authenticated by the Italian consulate certifying its compliance to the original documents.

The published works must be submitted in the original language and, except for selections in language subject areas, accompanied by a translation in one of the following languages: Italian, Latin, French, English, German and Spanish, certified as in compliance with the original text and drawn by the competent diplomatic or consular representation, or by an official translator.

Works published in Italy must comply with the obligations provided by D.P.R.252/2006. Works published abroad must state the date and place of publication. Compliance with these obligations must be certified by adequate documentation, enclosed with the application, or by self-certification of the candidate.

Reference to documents and published works already submitted to the University of Trieste for other selections is not allowed.

The University of Udine reserves the right to verify the truthfulness of the selfcertifications contained in the application for the selection and in the curriculum. If the content of the self-certifications is found to be untruthful, the declarant shall forfeit any benefits resulting from the provisions made on the basis of the false statements, without prejudice to the provisions of section 76 of D.P.R.445/2000. The withdrawal of the fellowship can be decided at any time, with reasoned resolution, even after the fellowship contract has entered into force.

4.2 Research project

The research project shall provide for a duration of 12 months, and shall mandatorily end by 30th April 2015.

The candidates must undertake to spend at least 90% of the project duration at a research centre of Friuli Venezia Giulia: the research activity shall mandatorily be conducted at a Department of this University, and possibly at the regional premises of the member Institutions of CER -Coordinamento degli Enti di Ricerca / Coordination of Research Institutions (<http://www.area.trieste.it/opencms/opencms/area/it/CER/>). The remaining part of the project duration can be spent working at other research centres, such as the member universities of the Alps-Adriatic Rectors' Conference, of the Danube Rectors' Conference, or other public or private research centres maintaining institutional relations with a member of the above Conferences and located in the area defined in Annex B); other research centres located in Friuli Venezia Giulia are excluded.

The Department hosting the fellow researcher shall support the activities provided for in the project, guaranteeing access to and use of the facilities, materials and services necessary to implement the project, and offering scientific supervision through its permanent and temporary teaching and research personnel, who shall thus undertake the role of scientific supervisor of the research fellow. The chosen scientific supervisor shall not be a member of any examining board for the selection procedures of any action funded by the DIANET project of this University.

The project can furthermore provide for the presence of one or more research centres, as above mentioned, contributing to the research by offering their technical and scientific know-how, facilities

and services as deemed necessary, and by hosting the research fellow at their premises. The research centre shall provide the research fellow with the appropriate declaration, signed by the legal representative or by a delegate, stating its commitment to give the research fellow access to and use of its facilities during his/her period of research stay, and provide him/her with a scientific supervisor. The following details must be included in the project:

- research title
- Scientific-Disciplinary Sector or Public Selection Sector
- Department and scientific supervisor
- list and information of the research institutions involved in the project specifying the scientific supervisor
- description of the objectives to be achieved
- description of the research, including methods to be used
- preliminary time schedule of the research activities

The project must be undersigned by the candidate and countersigned for validation by the scientific supervisor of the Department where the project will be conducted. The research project and its annexes are an integral part of the application.

4.3 Exclusion from the selection procedure and withdrawal

Candidates are admitted with reserve to the selection procedure for which they have applied. Exclusion from the selection procedure due to lack of necessary requisites is decided with reasoned Rector's Decree.

To withdraw from selection after submitting their applications, candidates must send written notice to "Magnifico Rettore dell'Università degli Studi di Udine – Area Servizi per la Ricerca, Ufficio Formazione per la Ricerca – Via Palladio 8, 33100 UDINE -Italy", enclosing a photocopy of valid passport or identity document.

5. Examining board

The examining board is composed of a minimum of three members chosen among the permanent university professors and researchers. Members of the examining board must not be related within the fourth degree of consanguinity or affinity to the candidates.

The examining board is nominated with Rector's Decree before the selection procedure takes place.

The members of the examining boards for the DIANET project shall not take part in other activities regarding the implementation of the project (for instance scientific supervision of the candidates).

6. Evaluation criteria

The total score will be based on a maximum of 100 points. The evaluation is divided in two phases. In the first phase academic qualifications and published works are evaluated according to the criteria provided by the board (max 50 points). Only texts published or accepted for publication from 2010 shall be evaluated.

In the second phase the research project is evaluated (max 50 points) according to the following criteria:

- 1) value of the research project;
- 2) quality of the research project, with a focus on methods and time schedule of the activities.

Candidates with a score of or above 35/50 in the evaluation of academic qualifications and published works shall be evaluated for the research project, which must be receive a score of at least 35/50.

Those candidates who receive at least 35/50 in both evaluation phases, and who therefore have a total score of or above 70/100, shall be included in the ranking list.

7. Results of the evaluation and ranking list

At the end of the selection procedure the examining board will draw up the general merit ranking list. Should two or more candidates receive the same score, the research fellowship will be awarded to:

- the female candidate
- the youngest candidate
- the candidate holding a PhD degree or degree awarded by medical schools of specialization.

Within 30 days from the submittal by the board, the selection proceedings and the ranking list of the candidates will be approved with Rector's Decree which will be published in the Official Bulletin of the University on the University website: http://www.uniud.it/ateneo/normativa/albo_ufficiale.

8. Awarding and regulation of the research fellowship

The candidates awarded with the research fellowship will be informed through registered post with acknowledgement of receipt.

The research fellowship is awarded to the winner of the selection through a specific contract, which is not a contract of employment and does not give any right to be employed by universities.

The research activity shall start on the first day of the month following the one when the contract is signed.

The start of the research activity may be postponed in case of serious and documented reasons. The payment of the fellowship will accordingly start on the day when the research actually starts.

In any case the research activity shall start no later than 1st January 2014.

The gross amount per year of the research fellowship is Euro 19,367.00 (nineteen thousand three hundred sixty-seven euros and 00 cents) and is paid by monthly instalments.

This amount is exempt from tax withholding and includes social security contributions to be paid by the research fellow. The fiscal and social security treatment of the research fellowship is in accordance with the provisions of section 4, L.476/1984, and of paragraph 26 et seq., section 2, L.335/1995 as amended.

In case of further funds available at the Department where the research activity is conducted, the fellowship can be renewed within the limits of the current legislation for further periods of at least 12 months. The request for fellowship renewal must be made by the Department involved at least 1 month before the contract expires. In any case the renewal period cannot be financed through the European Social Fund.

Payments will be made to the current account of the research fellow.

The fellowship holder must insure himself against accidents in the workplace for the whole project implementation period.

The research fellowship cannot be held contemporarily with other fellowships and scholarships of any kind, with the exception of those awarded by Italian or foreign institutions with the aim of integrating the research activity of the holders with a period spent abroad.

The fellowship holder can carry out another activity, subject to prior approval by the Scientific supervisor.

9. Duties of the research fellowship holder

The fellowship holder shall comply with the disciplinary and safety measures in force at the host institution and at the possible partner institutions. The fellowship holder shall moreover comply with the plan of activities provided by the project.

The research activity shall be conducted as follows:

- a) in a continuous and not merely occasional way and in coordination with the overall activity of the host institution;
- b) in close relation with the implementation of the research programme;
- c) in an autonomous way, within the limits of the arranged programme, without any pre-established work schedule.

The holder of the research fellowship must submit to the Department and to the Area Servizi per la Ricerca – Ufficio Formazione per la Ricerca of the University of Udine, the following documents:

- a three-monthly report on the conducted activities, undersigned by the research fellow and

validated by the scientific supervisor, within 20 days from the end of the relative period.

- the final report of the ESF project, undersigned by the research fellow and validated by the scientific supervisor and by the supervisor of the partner institutions, if applicable, within 30 days from the end of the research period.

The research final report must show that the objectives provided by the project have been achieved, listing any corrective action taken without compromising the successful outcome of the project.

Should the research fellow not comply with the provisions of the fellowship contract, the Head of the Department shall immediately inform the University.

Should the research fellow fail to submit the reports on the conducted activities within the time limits provided by the third paragraph of this item, an injunction will be issued to comply within 10 days.

Should the research fellow still not comply, the University reserves the right to terminate the contract and request the complete or partial return of the amount paid to the research fellow.

Should the Department, on proposal of the scientific supervisor, express a negative judgement on the activity of the research fellow, the University may decide to terminate the contract.

10. Early termination of the project

Early termination of the project, with recognition of the expenses incurred up to the termination date, is allowed only if one of the following occurs:

- a) permanent health reasons of the researcher, certified by the public health service, which do not allow the prosecution of the research project;
- b) serious family reasons, duly documented, which do not allow the prosecution of the project;
- c) signing by the fellowship holder of an employment contract or contract for service with better conditions than the one signed for the research activity under way. The certificates relevant to a) and b) must be submitted by the fellowship holder together with the declaration of early termination of the project.

The documentation relative to the new employment contract or contract for service referred to in c), must accompany the project final financial statement of the expenses incurred.

Early termination of the contract for other reasons than those listed in items a), b) and c) will result in forfeiture of the fellowship and associated obligation to repay the amounts received up to time of termination.

11. Suspension of the project

The research project may be suspended in the following cases:

- a prolonged and duly documented illness which entails the suspension of the fellowship;
- maternity leave. During the compulsory maternity leave, the contribution paid by the INPS (Italian National Social Security Service) in accordance with section 5 of D.M. of 12th July 2007, will be complemented by the University up to the entire amount of the research fellowship, according to L.240/2010.

An absence for a period of less than 30 days in one year is not considered to be a suspension of the project.

12. Results and patents / Property rights

The outcomes of the research project, such as any patents and industrial property rights, together with any related economic exploitation rights, belong to the University of Udine, possibly in co-ownership (for their respective quotas of inventive contribution) with other research centres or institutions involved in the project. In all cases the current legislation on the subject, in particular D.Lgs.30/2005 "Industrial Property Code" as amended, and the University's internal regulations on the subject are applied, without prejudice to the right of the research fellow to be acknowledged as author/inventor. The owners of the research outcomes shall give them widespread dissemination, expressly mentioning that they have been achieved thanks to the funds of the 2007/2013 European Social Fund Operational Programme of the Autonomous Region Friuli Venezia Giulia.
