**UNIVERSITY OF UDINE
RECTORAL DECREE**

SUBJECT: public selection procedure for the recruitment of a fixed-term researcher at the Department of Humanities and Cultural Heritage (formerly the Department of History and Preservation of Cultural Heritage) for the sector competition 10 / A1 Archaeology, pursuant to Article 24, paragraph 3, letter a) of Law 30.12.2010, n. 240 - D.R. n. 856 of 12.22.2015 - notice published in the Official Gazette n. 5 of 01.19.2016
Updated announcement and reopening terms

THE RECTOR

SEEN the D.R. n. 856 of 12.22.2015, notice of which was published in the Official Gazette n. 5 IV special edition dated 19/01/2016, which was issued a public selection procedure for the recruitment of a fixed-term researcher at the Department of History and Preservation of Cultural Heritage for the sector competition 10 / A1 Archaeology, under art. 24, paragraph 3, letter a) of Law 30.12.2010, n. 240;

WHEREAS, as a result of departmental reorganization, from 1/01/2016 the scientific sector L-ANT/10 "Methods of Archaeological Research" has been assigned to the Department of Humanities and Cultural Heritage, which, therefore, is the reference framework for the initiated competition proceedings;

SEEN the note dated 02.15.2016 by which the President of the Federation of Underwater Archaeologists highlights some possible critical issues of the competition notice;

SEEN the decision of the Director of the Department of Humanities and cultural heritage, n. 9/2016 dated 26/02/2016, with which is more clearly identified the admission requirements of the modified comparative evaluation replacing those which were previously approved by the Board of the Department of History and Preservation of Cultural Heritage on 16/09/ 2015, in order to allow a wider possibility of a high professional competence selection and thus making the competition proceedings to be more closer to the principles of the European Charter for researchers and the Code of Conduct for the recruitment of researchers;

RESEEN the opportunity to make some changes in the wording of the notice, issued by D.R. n.856 dated 22/12/2015 and, simultaneously, extending the deadline to allow the submission requests to participate in the proceedings,

DECREES

Art. 1 - For the motivations indicated in the introduction of art. 2 of D.R. n. 856 dated 22/12/2015 is amended as follows:

Article 2

Requirements for admission to the comparative assessment

The procedure is open to Italian and foreign citizens having at least one of the following qualifications in the appropriate field of study and research:

- Ph.D. or equivalent;
- Master's degree (laurea magistrale), or equivalent, together with a professional scientific curriculum suitable for the carrying out of the research activities.

Pursuant to art. 6 , clause 2, of the University Regulations the following is also required:

- Proven performance of research and teaching activities under code L-ANT/10 Methodologies of archaeological research;
- Thorough knowledge of the problems concerning the methods of archaeological research, especially in underwater rivers.

The adjudicating commission shall evaluate the above requirements.

The following categories are excluded from the comparative assessment:

- full and associate professors and researchers with permanent positions in Italian Universities, even if they have retired;

- those who have already had contracts with research grants and fixed-term researchers pursuant to arts. 22 and 24 of Law 240/2010 at the University of Udine or other Italian Universities, state-run or not, or on-line, and also those Bodies pursuant to clause 1 art. 22 of Law 240/2010, for a period which, added to the overall duration of three years envisaged for the contract announced, exceeds a total of 12 years, even if not continuously. For the purposes of the duration of such relationships, any periods spent on maternity leave, or for health reasons according to current legislation, shall not be considered;
- those who have any degree of family relationship or affinity, up to the fourth degree, or are connected by marriage, with a professor or permanent researcher belonging to the Department proposing to issue the contract (Department of Humanistic studies and cultural heritage; list accessible on the link <http://www.uniud.it/it/ateneo-uniud/concorsi-bandi-uniud/concorsi/bandi-docenti-ricercatori/ricercatori-tempo-determinato-uniud>), or with the Rector, the Administrative Director or any component of the University Board of Governors (<http://www.uniud.it/ateneo/organizzazione/organ/composizione.htm>);
- those who are excluded from civil and political rights;
- those who have been dismissed or dispensed from a position at a Public Administration due to a persistent unsatisfactory performance;
- those who have been dismissed from another State position pursuant to art. 127 letter d) of Presidential Decree n. 3 of 10/1/1957.

The requirements must be possessed on the date when the deadline for presenting the application for admission to the procedure expires.

Candidates are admitted to the comparative assessment only conditionally, and exclusion from the procedure due to a lack of the requirements is decided by a justified decree by the Rector, and notified to the candidate concerned.

The Administration guarantees equality and equal opportunities to men and women for access to and treatment in the workplace.

Art. 2 - The deadlines for submission of participation applications for the public selection procedure for the recruitment of a fixed-term researcher at the Department of Humanities and Cultural Heritage for the sector competition 10/A1 Archaeology, under art. 24, paragraph 3, letter a) of Law 30.12.2010 , n. 240 , made by means of D.R. n. 856 dated 22/12/2015, will be reopened for a period of thirty days from the day following the day of publication of this decision in the Official Gazette of the Italian Republic.

Art. 3 - Valid applications received under the tender procedure with the D.R. n. 856 dated 22/12/2015 remain acquired, with the candidates right to modify or integrate them within the time specified in Art. 2.

Art. 4 - The Department of History and Preservation of Cultural Heritage, no longer active since 1/01/2016 and mentioned in the D.R. 856 of 22/12/2015, has been replaced by the Department of Humanities and Cultural Heritage.

Art. 5 - The application forms have been amended in accordance with the hereof provisions.

Art. 6 - Remains unchanged in the remaining provisions of the cited D.R. 856 dated 22/12/2015.
