2. The receiving institution will send its decision within the following time frame:

**DREGENSB01:** We accept all students that are nominated by the partner institution. Official letters of acceptance will be sent out to the students within **6** weeks after the deadline for application.

#### Partner Institution:

- 3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]
- 4. Termination of the agreement

This agreement will be in effect for the full duration of the ERASMUS+ Programme. In case of premature termination, a notice of at least one academic year will be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

2. I UDINE01 will send a detailed Erasmus nomination list by e-mail. It cannot be guaranteed another modality to nominate Erasmus students from I UDINE01.

- 3. Partner Universities have to send a detailed Erasmus nomination list by e-mail (to <a href="iss@uniud.it">iss@uniud.it</a>). I UDINE01 cannot guarantee the acceptance of another modality to nominate Erasmus students by partner Universities (such as online nominations etc...).
- 4. I UDINE01 will send its decision (information package) within 8 weeks at the maximum from the reception of the nomination letter.
- 5. Erasmus incoming student at I UDINE01 has to collect the Transcript of Records before leaving Udine, otherwise the Transcript of Records will be issued and sent by I UDINE01 no later than 5 weeks directly to the personal post address of the student.
