- Erasmus incoming student at **I UDINE01** has to collect the Transcript of Records before leaving Udine, otherwise the Transcript of Records will be issued and sent by I UDINE01 no later than 5 weeks directly to the personal post address of the student.
- D WIESBAD01: Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.

Termination or modification of the agreement:

A unilateral decision to discontinue or to change the exchanges notified to the other party by September 20/../ will only take effect from the October of the following new academic year.

Grading system of RheinMain University:

The grading system comprises five levels with numerical equivalents:

"sehr gut" (1.0, 1.3) = very good; "gut" (1.7, 2.0, 2.3) = good; "befriedigend" (2.7, 3.0, 3.3) = satisfactory; "ausreichend" (3.7, 4.0) = sufficient; "nicht ausreichend" (5) = non-sufficient/fail. The minimum passing grade is "ausreichend" (4.0).

2.Visa
