

# CALL FOR APPLICATIONS FOR THE SELECTION OF STUDENTS FROM THE UNIVERSITY OF UDINE FOR A STUDY MOBILITY PERIOD AT PARTNER NON-EU UNIVERSITIES

# APPLICATION DEADLINE: DECEMBER 11th, 2025, 12:00 PM

The University of Udine, within the framework of its Internationalization Projects, is launching a call for applications for a study mobility period at partner non-EU universities.

The host institutions are divided by geographical area and/or field of study into 5 separate calls.

#### 1. Eligibility Requirements for Application

Applicants must meet the following requirements, under penalty of disqualification:

- Be regularly enrolled in the 2025/2026 academic year in a bachelor's or master's degree program at the University of Udine (students in the second year of a master's degree program are excluded);
- Be up to date with the payment of tuition fees at the University of Udine;
- Be enrolled in the degree program(s) associated with the partner foreign university;
- In the case of enrolment in an inter-university degree program, the student's home university must be the University of Udine;
- Students enrolled in a bachelor's degree program who expect to graduate before the start of the mobility period (extraordinary session of the 2024/2025 academic year or first graduation session of the 2025/2026 academic year) may apply by indicating a future academic career in order to carry out the mobility only if they enrol in the 2026/2027 academic year. Departure will be subject to actual and regular enrolment in the master's degree program at the University of Udine.

Due to the unavailability of host institutions to accept students, students enrolled in the following degree programs are not eligible to apply Medicine and Surgery, Health Professions, Law, and Primary Education Sciences.

#### 2. Choice of Destinations

The call includes five separate selection procedures, divided by geographical area and/or degree programs.





Each selection procedure is associated with one or more host universities, based on inter-university agreements signed between the University of Udine and non-EU partner institutions.

Each student may apply to a maximum of two selection procedures that include their degree program. Within each procedure, the student may indicate two preferences, for a total of four possible choices.

#### Example:

A student interested in both Selection Procedure 1 – Australia and Selection Procedure 2 – Canada may choose up to 2 universities in Australia and 2 in Canada.

In selection procedures that include multiple host universities, the order of preference indicated by the applicant will not be considered as a priority criterion for the selection process.

Selection will be carried out through separate and independent rankings for each procedure, based solely on the selection criteria outlined in Section 6.

#### 3. Application Procedure

To apply for the program, students must complete the online application available on ESSE3 within their personal profile and must attach to the application the PROPOSED Study Plan Abroad. #### 4. Application Deadline

Students must complete the online application, indicating their chosen destination(s), no later than <a href="https://doi.org/10.1007/journal.com/">DECEMBER 11th, 2025, AT 12:00 PM</a>

It is the applicant's responsibility to print and keep a copy of the submitted application for future reference. A hard copy of the application must not be submitted to the Office of Mobility and International Relations.

#### 5. Grounds for Exclusion

Applicants will be automatically excluded from the selection process if their application is:

- a) submitted after the deadline;
- b) missing any of the eligibility requirements;
- c) not completed through the ESSE3 platform;



- d) missing the Proposed Study Plan Abroad.

#### 6. Selection Criteria

Each selection procedure will have its own separate and independent ranking.

The selection will be based on the following evaluation criteria, for a maximum total score of 120 points:

- Academic record, for a maximum of 60 points (with a maximum of 30 points for first-year bachelor's students);
- Motivational interview, for a maximum of 60 points.

The score will be assigned based on the algorithms described below.

Only applications that are complete in all required parts will be considered for selection and assignment of the destination.

The ranking score will be calculated as follows:

• For students enrolled in the first year of a bachelor's degree program in the 2025/2026 academic year\*:

High school final grade converted to a 30-point scale + 6 points.

To this, a score from 0 to 60 points assigned by the faculty member responsible for the exchange is added. The assigned mobility can only be confirmed and carried out if the student has earned at least 12 ECTS credits (CFU) by July 31, 2026;

As for foreign qualifications, final grades from high school diplomas or university degrees will be evaluated and converted to the Italian grading system. For students enrolled in the first year of a master's degree program in the 2025/2026 academic year:

Bachelor's degree final grade converted to a 30-point scale + 1.5 points (if the degree was awarded cum laude) + [standard number of years for the bachelor's degree / (AY bachelor's graduation – AY enrolment + 1)] \*30.

To this, a score from 0 to 60 points, assigned by the selection committee during the oral interview, will be added.

 For students enrolled in years beyond the first (N > 1) — whether on track (FC = 0) or beyond the regular duration of the program (with FC years):

[ECTS/(N+FC-1)\*60)]\*30 + weighted average grade.

To this, a score from 0 to 60 points, assigned by the selection committee during the oral interview, will be added.

The weighted average and ECTS credits (CFU) will be calculated based on the grades recorded in the transcript as of 30 September 2025.

For students completing their bachelor's degree (N = 3) in the graduation sessions of the 2024/2025
academic year (last enrolment in a.y. 2024/2025), whether on track (FC = 0) or beyond the regular
duration (with FC years):

[ECTS/(N+FC) \*60)]\*30 + weighted average grade.

To this, a score from 0 to 60 points, assigned by the selection committee during the oral interview, will be added.

The weighted average and ECTS credits (CFU) will be calculated based on the grades recorded in the transcript as of 30 September 2025.

All students may take part in the mobility program only if they are regularly enrolled in the 2026/2027 academic year prior to the departure for their study stay.

Students who graduated from other Italian universities must enter their bachelor's degree final grade in their personal ESSE3 page before the application deadline.

NB: When submitting the application on ESSE3, it is mandatory to fill in the field requesting the year of enrolment in the bachelor's or single-cycle degree program that qualifies the student for the current course of study:

- Enrolled in a bachelor's or single-cycle degree program: enter 0;
- Enrolled beyond the first year of a master's degree program: enter 0;
- Enrolled in the first year of a master's degree program: enter the numerical value of the year of enrolment (for example, enter 2020 for the academic year 2020/2021).

#### **Motivational Interview**

The committee evaluates the application by assigning from 0 up to a maximum of 60 points based on:

Activities proposed in the study project abroad: 10 points;





- Language proficiency level, if certified or self-certified: **30 points**\*;

\*B1 Level – 10 punti; B2 Level – 15 punti; C1/C2 Level - 25 punti.

An additional 5 points will be awarded only if the applicant holds one of the following certifications: Cambridge English (CAE), IELTS, TOEFL. **No other certifications are accepted** for this selection.

The University language certification issued by CLA is not valid.

- Motivational Interview: 20 points.

N.B: Only the above-mentioned certifications (CAE, IELTS, TOEFL) can be attached on ESSE3.

Applicants who do not attend the interview on the date set by the committee will be automatically excluded from the selection.

Interviews will be held between 12 and 23 January 2026 via Microsoft Teams or in person. Selected students will receive a monthly mobility grant (Finanziamento MUR Fondo Giovani per la mobilità). The number of months indicated in the tables for each selection is not final and may vary slightly depending on the duration of the academic periods at the host universities.

- Additional monthly TOP UP contribution of €250, upon submission of the ISEE 2026 Declaration according to the annual Ministerial Decree related to LEP (Essential Levels of Performance);
- Possible additional contribution, if available, up to a maximum of €500 for partial reimbursement of visa and/or health insurance expenses.

Additional funding may be available from the Regional Agency for the Right to Study (ARDIS), which publishes an annual call for supplementary financial grants for students in mobility. #### 8. How to apply

Students must:

- Log in to ESSE3 with their credentials;
- Complete the online application available under the menu item "BANDI DI MOBILITÀ";
- Select "Bando Extra EU";
- Choose the preferred destinations and upload the required documents;
- Print the final version of the application before the deadline.

By submitting the "STAMPA DEFINITIVA" the application is considered closed and data cannot be modified thereafter.

The Learning Agreement to be followed during the mobility will be prepared by the student **only after** the official assignment of the foreign host institution.



# CALL N.1 - AUSTRALIA

All students enrolled in a bachelor's or master's degree program at the University of Udine are eligible to apply, except for students enrolled in the degree programs in Medicine and Surgery, Health Professions, Law, and Primary Education Sciences.

Eligible mobility period: from July/August to November/December 2026.





# CALL N. 2 - CANADA (English or French)

All students enrolled in a bachelor's or master's degree program at the University of Udine are eligible to apply, except for students enrolled in the degree programs in Medicine and Surgery, Health Professions, Law, and Primary Education Sciences.

# CALL N. 3 - ASIA (SOUTH COREA, MALAYSIA E TAIWAN)

All students enrolled in a bachelor's or master's degree program at the University of Udine are eligible to apply, except for students enrolled in the degree programs in Medicine and Surgery, Health Professions, Law, and Primary Education Sciences.

#### 10. Additional Information

- Selected students, thanks to their status as "Exchange Students," will be exempt from paying tuition fees at the host institution but must remain in good standing with fee payments at the University of Udine for the entire duration of their stay abroad;
- Selected students must independently contact the embassies or consulates of the destination countries for visa procedures, if a visa is required by the host country, and must arrange their own health insurance;
- Final acceptance is subject to the favourable and indisputable approval of the host universities, also considering any changes made to their academic offer and the possession of any language certifications required by them.

#### 11. Procedure Responsible

According to Article 4 of Law 241 of 7 August 1990 "New rules on administrative procedure and the right of access to administrative documents", the Responsible Officer for the procedure is Dr. Cristina Disint, Head of the Student Services Area at the University of Udine.

Candidates have the right to access the documents of the selection procedure in accordance with the provisions of Articles 1 and 2 of Presidential Decree No. 352 of 23 June 1992 (Regulation governing the exercise of the right to access and the cases of exclusion from the right to access administrative documents, in implementation of Article 24, paragraph 2, of Law No. 241/90, which introduces new rules on administrative procedures and the right to access documents), as amended and supplemented.
