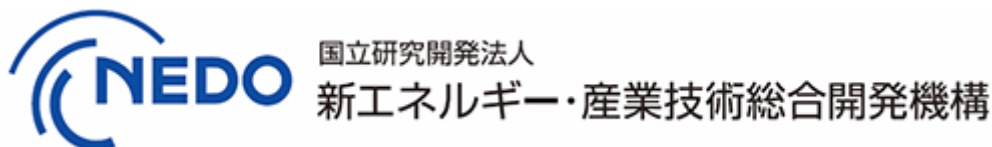

## ANGELINI PHARMA E INCIPIT (ITALIAN NETWORK FOR PAEDIATRIC CLINICAL TRIALS) - Bando Angelini for Future 2021

Angelini Pharma e INCIPIT lanciano la prima edizione del bando Angelini for Future 2021 per sostenere progetti di ricerca indipendenti nelle malattie rare. Il bando è rivolto a sperimentatori europei laureati che lavorano in organizzazioni sanitarie pubbliche o private non profit (università, fondazioni di ricerca e organizzazioni senza scopo di lucro). L'obiettivo del bando è sostenere la ricerca sul repurposing di farmaci nelle malattie rare o in condizioni con elevate esigenze mediche insoddisfatte nel SNC, con l'obiettivo di identificare e sviluppare nuovi trattamenti con farmaci già disponibili, ma non ancora specificamente studiati nei pazienti affetti da tali malattie. Le proposte dovrebbero affrontare questioni chiave in sospeso sia in fase preclinica che in fase clinica iniziale. Angelini stanziava 300.000 euro per finanziare fino a due progetti di ricerca in fase preclinica avanzata o in fase clinica precoce. Un massimo di 100.000 euro è previsto per le proposte che riguardano lo studio preclinico.

## JUSTICE PROGRAMME 2021-2027 - Calls for project proposals

Under the JUSTICE PROGRAMME 2021-2027 four calls are now open:

### 1. Call for proposals for action grants to support national or transnational e-Justice projects (JUST-2021-EJUSTICE).

The key objective of the call for proposals is to contribute to achieving the goals of the European e-Justice Strategy and Action Plan 2019-2023 by supporting the implementation of e-Justice projects at the European and national level, as far as they have a European dimension. Proposals aiming to develop projects on the main list of the Council e-Justice Action Plan will have priority over other projects indicated in the Action Plan.

The consortium must include at least one public body, private non-profit organisation or international

Deadline **06.05.2021** at 17.00 CET.

## **2.Call for proposals for action grants to promote judicial cooperation in civil and criminal matters (JUST-2021-JCOO)**

The aim of this call is to contribute to the effective application of the EU acquis relating to judicial cooperation in civil and criminal matters, strengthening mutual trust. The main objectives are to facilitate and support judicial cooperation in civil and criminal matters, and to promote the rule of law, independence and impartiality of the judiciary, including by supporting the efforts to improve the effectiveness of national justice systems, and the effective enforcement of decisions.

Priorities 1 and 2: the applications must be transnational and involve organisations from at least two participating countries; The consortium must include at least one public body, private non-profit organisation or international organisation as beneficiary (not as affiliated entity; duration: between 12 and 24 months; the EU grant applied for cannot be lower than € 75 000. Priorities 3 and 4: restrictions apply.

Deadline **06.05.2021** at 17.00 CET

## **3.Call for 4-year Framework Partnership Agreements to support European networks active in the area of facilitating and promoting judicial cooperation in civil and/or criminal matters and in the area of access to justice (JUST-2021-JCOO-JACC-OG-FPA)**

The objective of the Call is to facilitate and support judicial cooperation in civil and criminal matters, and promote the rule of law, independence and impartiality of the judiciary, including by supporting the efforts to improve the effectiveness of national justice systems, and the effective enforcement of decisions.

Specific requirements for established formal network; The foreseen duration of activities under the FPA is 48 months.

Deadline **06.05.2021** at 17.00 CET

## **4.Call for proposals for action grants to support transnational projects on training of justice professionals covering civil law, criminal law or fundamental rights (JUST-2021-JTRA)**

In line with the Commission Communication 'Ensuring justice in the EU — a European judicial training strategy for 2021-2024', the objective of the call is to contribute to the effective and coherent application of EU law in the areas of civil law, criminal law and fundamental rights, as enshrined in the EU Charter of Fundamental Rights, and the rule of law related issues, by helping to address the training needs of justice professionals in these fields.

The applications must be transnational and involve organisations from at least two participating countries; the EU grant applied for cannot be lower than € 75 000; duration between 12 and 36 months.
